DREW LANZA CHAIR OF THE BOARD

Mr. Lanza was appointed as a Public member to the City of San Jose Police and Retirement Plan as a Board of Trustee in April 2011. His term expires on April 30, 2023. Drew serves on the Investment Committee and Disability Committee.

Drew has lived on the Peninsula since he was three years old. He attended Stanford University and Harvard. After College, Drew started five companies. For the past decade, Drew has been a venture capitalist. He works with others to help them start their own companies. Having sat on over two dozen Boards of Directors, he fancies himself a bit of an expert on what makes some boards highly effective. Drew is married to Jane and they have three children.



ANDREW GARDANIER VICE CHAIR OF THE BOARD

Mr. Gardanier is an Employee Fire Representative, appointed to the Board in December 1, 2015. His term expires November 30, 2023.

He has been with the San Jose Fire Department as a Fire Engineer for the last 10 years. In 2015, Mr. Gardanier was appointed to the Board of Trustee for the City of San Jose Police and Fire Retirement Plan. Mr. Gardanier serves on the Investment Committee and the Joint Personnel Committee (JPC).

Prior to working for the City of San Jose, he was a Workplace Consultant for Kaiser Permanente. At Kaiser, he spent time working with clients evaluating, developing, and implementing changes to decrease employee risk of injury on the job. HOWARD LEE

Mr. Lee is a Public member appointed to the Board February 2020. His current term expires November 30, 2022. Mr. Lee serves on of the Audit Risk Committee and on the Governance Committee.

Mr. Lee has more than twenty-one years of experience in venture capital and private equity investing in Silicon Valley, and more than a decade of experience in research, development, and marketing in emerging and established technology companies and research institutions. His investments have spanned venture capital, venture and private equity funds, and venture secondary.

Most recently, Mr. Lee is a Co-Founder and Managing Director of Founders Equity Partners (FEP), a venture secondary fund focused on the cybersecurity sector. He has held management positions in product management at Applied Materials, has worked as a research investigator at the US Army Research Labs, and in a variety of engineering roles at IBM and Unisys.

He serves as an advisor and mentor to several Silicon Valley organizations including the Entrepreneurship course at the University of California at Berkeley.

Mr. Lee holds a BS and a PhD in Electrical Engineering from Cornell University, and an MBA from INSEAD in Fontainebleau, France.



ESWAR MENON

Mr. Menon was appointed as a Public member to the City of San Jose Police and Retirement Plan as a Board of Trustee on December 1, 2018. His current term expires on November 30, 2022. Mr. Menon serves as Chair of the Investment Committee and serves on the Joint Personnel Committee (JPC).

Eswar Menon is the Founder & CIO of Harper Capital Management. He is also a Trustee and Chair of the Investment Committee for the San Jose Police & Fire Retirement Fund. Additionally, Eswar is an Advisor to Sameeksha Capital. Over his twenty-five-year career in Asset Management prior to starting Harper Capital Management, Eswar has worked at Nicholas Applegate Capital Management, Loomis Sayles & Co., Denahi Global Investments, WHV Investment Management and Geneva Advisors.

His experience includes managing investments in Global Equity, Balanced Funds, Real Estate and Private Markets. Eswar holds an undergraduate degree in Electrical Engineering from the Indian Institute of Technology, Madras, a graduate degree in Electrical & Computer Engineering from the University of California, Santa Barbara, and an MBA from the University of Chicago.



NICK MUYO

Mr. Muyo was appointed as a Retiree member to the City of San Jose Police and Retirement Plan as a Board of Trustee in November 2012. His term expired on November 30, 2020. Mr. Muyo will stay on the Board until a replacement is appointed. Mr. Muyo serves on the Governance Committee and the Audit/Risk Committee.

Mr. Muyo is a 37-year law enforcement veteran, having worked for the Berkeley Police Department, the San Jose Police Department and the Santa Clara County Office of the District Attorney. Nick retired from full time duty in April 2012, but continues to work as a security consultant and as an Instructor with Third Degree Communications.



RICHARD SANTOS

Mr. Santos was re-appointed as a Retiree member to the City of San Jose Police and Retirement Plan as a Board of Trustee in March 2011. His current term expires November 30, 2022. Richard is the Chair of the Disability Committee and serves on the Governance Committee.

Richard retired as a Fire Captain from the San Jose Fire Department with 33 years of service. During his tenure at the San Jose Fire Department, he was elected Vice Chair for 12 years on the San Jose Police and Fire Retirement Board. In the year 2000, Richard Santos was elected to the Santa Clara Valley Water District Board to represent District 3. He is the representative for the residents of Sunnyvale, Alviso, Milpitas, Berryessa and Alum Rock communities, and areas east of Highway 101 to the Evergreen community area.

Mr. Santos is a representative of the San Jose Firefighters local 230 union. Richard was appointed by the San Jose Mayor and City Council to the Envision San Jose 2040 General Plan 37-member task force, and recognized as "Citizen of the Year for 2006" by the Berryessa Citizen Advisory Council.

Mr. Sunzeri, a graduate of San Jose State University, received a B.A. in Business Administration, with a concentration in Finance and a minor in Economics. In 1988, he joined PaineWebber/UBS Financial Services where he spent 21 years. Vince and his team joined Morgan Stanley in 2009. Vince is Senior Vice President of Investments. Vince is the President of the Rotary Club of San Jose Foundation Board of Trustees.

Vince is dedicated to continuing to enhance his professional knowledge and expertise. He has received the designation of Certified Investment Management Analyst (CIMA®) through the Wharton School of Business. FRANCO VADO

Mr. Vado is a Police Active Representative, appointed to the Board in February 2016. His term expires in November 30, 2021. Mr. Vado is the Chair of the Audit/Risk Committee and serves as an alternate on the Governance Committee.

In 1995 Mr. Vado began his Law Enforcement career with the City of San Jose Police Department. He was elected as Director of the San Jose Police Officers' Association in 2009 and was elected to Chief Financial Officer in July 2010. Mr. Vado served four years on the Deferred Compensation Advisory Committee and is currently a Trustee on the PORAC Insurance and Benefits Trust since November 2010.



PAM FOLEY

Councilmember Pam Foley was elected to the San José City Council in November 2018, representing the residents of City Council District 9. The council district is located between Willow Glen and Almaden Valley, in the southwest corner of San José, bordering Campbell and Los Gatos.

Since 2004, Pam has served as a Trustee on the School Board for the San José Unified School District. She oversaw the education of 31,000 students and a budget of \$400,000,000. In December 2017, she completed her third term as Board President.

Mayor Sam Liccardo appointed Pam to the San José Learns Task Force, where they created a framework for awarding grants to elementary schools with innovative strategies to improve reading levels for K-3 grade students.
